

FINAL MINUTES Regular Meeting Board of Directors Monterey Peninsula Water Management District June 17, 2013

The meeting was called to order at 7:00 p.m. in the District's conference room.

The assembly recited the Pledge of Allegiance.

Ronald Cohen, Managing Director of Public Water Now, announced that the organization will sponsor an initiative to be placed on the June 2014 ballot that would call for public ownership of the California American Water Distribution System by the Water Management District either through cooperative purchase agreement or eminent domain. He invited the public to attend a town hall meeting regarding public ownership on June 18, 2013 at 7:30 pm.

Director Lehman offered a motion that was seconded by Director Lewis to approve the Consent Calendar items. The motion was adopted unanimously on a vote of 5 – 0. Directors Brower, Byrne, Lehman, Lewis and Pendergrass voted in favor of the motion. Directors Markey and Potter were absent.

A summary of General Manager Stoldt's report is on file at the District office and can be viewed on the District's website. He noted that between October 2012 and May 31, 2013 rainfall received was 69 percent of long-term average. Unimpaired flow was measured at 41 percent of long-term average, and water storage was 94 percent of the long-term average and 79 percent of system capacity. Due to low Carmel River flows, Water Management District staff were conducting fish rescues seven days a week which resulted in the rescue of 30,000 fish.

General Manager Stoldt reported that on June 5, 2013, Water Management District staff provided State Water Resources Control Board (SWRCB) members and their staff a tour of the Sleepy Hollow Fish Rearing Facility. Mr. Stoldt also met with Stephanie Marcus, Chair of the SWRCB about allowing water meters to be set for mixed-use commercial projects where there is no increase in water use. Stoldt advised the Board that the Monterey Peninsula Water Supply Project EIR should be complete by February 2014. He stated that the Monterey Peninsula Water Supply Project Governance Committee met on June 13, 2013 to receive a presentation from the California Polytechnic University San Luis Obispo team of architectural studies students tasked to develop the desalination facility design. The next opportunity to review the revised design would be August 1, 2013.

A summary of the report presented by Stephanie Pintar, Water Demand Manager, is on file at the District office and can be viewed on the Water Management District website.

Public Comment: Tom Rowley, member of the Monterey County Hospitality Association (MCHA), commended Stoldt and Pintar on the excellent presentation they gave to the MCHA on June 11, 2013 regarding water conservation requirements for the hospitality industry.

District Counsel Laredo reported that he provided information to the Board on items 3, 5 and 6. In addition, a report was provided by labor negotiators under item 4. No reportable action was taken.

Byrne reported that she and Brower participated in a June 11, 2013 meeting with representatives from the National Marine Fisheries Service that opened opportunities for further discussions about the Carmel River and the Los Padres Dam. Pendergrass announced that he and Byrne attended the June 4, 2013 meeting of the SWRCB in Monterey. Lewis advised that she has been active with public outreach, distributing flyers on water conservation and the Water Management District's rebate program. She noted that Orchard Hardware in Seaside has expressed an interest in allowing the Water Management District to set up a display table in the store so that staff could distribute rebate and water conservation information.

On a motion of Byrne and second of Brower, the July through September 2013 Quarterly Water Supply Strategy and Budget was adopted on a vote of 5 – 0. Directors Brower, Byrne, Lehman, Lewis and Pendergrass voted in favor of the motion. Directors Markey and Potter were absent. Brower offered a motion to adopt the FY 2013-14 Water Management District Budget and also Resolution 2013-10. The motion was seconded by Byrne and approved on a vote of 5 - 0. Directors Brower, Byrne, Lehman, Lewis and Pendergrass voted in favor of the motion. Directors Markey and Potter were absent.

Public Comment: Tom Rowley, Monterey Peninsula Taxpayers Association (MPTA), stated that the MPTA filed a lawsuit against the Water Management District challenging implementation of the water supply charge under the District's Ordinance No. 152. He urged the Board to place the water supply charge on the ballot for voter consideration, in order to avoid legal fees associated with the MPTA lawsuit. General Manager Stoldt responded briefly to Mr. Rowley's comments.

Byrne offered a motion to approve the restated reclamation project agreements, and authorize the General Manager to incorporate additional technical amendments as they are identified prior to final execution of the agreements. The motion was seconded by Lewis and approved unanimously on a vote of 5 - 0. Directors Brower, Byrne, Lehman, Lewis and Pendergrass voted in favor of the motion. Directors Markey and Potter were absent.

The following comments were received during the public comment period on this item. (1) Mark Stilwell, Executive Vice President of Real Estate for the Pebble Beach Company, expressed support for Board approval of the amended agreements so that new rates could be implemented on July 1, 2013. (2) Lloyd Lowrey, representing the Independent Reclaimed Water Users Group, requested that the Board approve the amended agreements.

Stoldt advised the Board that on June 18, 2013, the Monterey Regional Water Pollution Control Agency (MRWPCA) would conduct a public scoping session on the project EIR. He would attend and speak on the Water Management District's partnership with MRWPCA on funding the project. Members of the Board of Directors asked questions no action was taken.
