Dear Janice:

In accordance with MPWMD Rule 25.5, the following credit has been verified to be current as of this date at the site referenced above:

Credit for a 75 seat restaurant in a 1,846 square-foot space. This space, formerly the Spinning Wheel Restaurant, is currently vacant. Conversion of the previous restaurant use to Group I retail use leaves a transferable water credit for 58 restaurant seats. (1.16AF)

This Water Use Credit may be applied to future water use on that site or another site (pursuant to Ordinances No. 71 and 79) at any time within a period of 60 months from May 1, 1996. After the 60th month, renewal of this Water Use Credit will be allowed only upon proof that some or all water savings represented by the credit are current. If savings are not current, a pro-rata reduction will occur. A single renewal period of 60 months is allowed; thereafter any unused Water Use Credit expires.

This form should be presented to the Water Management District to utilize the credit.
