CHRONOLOGY OF EVENTS

FOR 3665 VIA MAR MONTE, APN #103-121-002

- 12 May 2002 Seller solicited Mr. King / purchase agreement written
- 20 May 2002 Purchase agreement accepted/ King begins feasibility study
- 20 May 2002 King purchases Well Permit #02-080
- 22 May 2002 King purchases Septic Permit #E-964 (in tandem w/well permit, can develop house)
- 22 May 2002 King purchases Encroachment Permit #2-400 to sawcut curb for well access road
- 06 August 2002 King meets with Granite Well Drilling and Clark Backhoe to discuss access road
- 08 August 2002 King Closes purchase
- 08 August 2002 King receives Granite Contract
- 12 August 2002 King, Mr & Mrs meet neighbors. 3675 Threatens litigation if King tries to build
- 19 August 2002 King buys Encroachment Permit #3-358 to remove two county owned trees at well access road entry to property
- 29 August 2002 Planning Application PLNG020418 process begun
- 30 August 2002 Grice Engineering completes design for grading map for well access roadway
- 09 October 2002 Grading Permit #GP020149 "Grading for access for well drilling (450cy)"
- 21 October 2002 AM/Actual grading begins on 3665 Via Mar Monte
- 21 October 2002 PM/Neighbor Ferry files suit
- 22 October 2002 AM/Ferry SHUTS DOWN JOB w/illegal obtained TRO
- 05 November 02 Ferry files additional multiple charges/ multiple suits
- 06 November 02 Ferry TRO DEFEATED. King ready to proceed except for Rain. More rain.
- 12 November 02 King begins again with access road.
- 13 November 02 Ferry SHUTS DOWN JOB AGAIN
- 14 November 02 Judge allows conditional TRO, permits well construction.
- 16 November 02 Ferry tries to have King arrested.
- 18 November 02 Ferry SHUTS DOWN JOB AGAIN
- 18 November 02 Granite WELL RIG AND WELL TENDER RIG FORCIBLY REMOVED by judge
- 11 December 02 King attempts to move ahead on Admin Permit but cannot with TRO restrictions
- 11 December 02 King petitions for removal of judge on 32 points of bias.
- 19 December 02 Judge is removed
- 19 December 02 Ferry hires new attorney
- 19 December 02 New judge removes TRO. Property too wet to do anything.
- 03 Feb 2003 Ferry gets INJUNCTION. King SHUT DOWN.
- 02 April 2003 King petitions to remove new judge
- 18 April 2003 New judge removed
- 02 May 2003 County tables Admin Permit pending due to INJUNCTION
- 07 May 2003 King gets 60 day extension from County on Well Permit
- 03 July 2003 King makes last ditch effort to remove INJUNCTION to drill well before extended well drilling permit expires. Denied
- 15 August 2003 JURY TRIAL/ Judge is excused. INDEPENDENT JUDGE from Sacramento assigned case; at the end of plaintiffs presentation, dismisses jury and makes rulings. All 34 false claims dismissed.
- Early October 2003 Granite WELL DRILLING RIG RETURNS/Well drilled in two days; Pump, and wellhead and WATER METER installed immediately. Then came the rain.
- 15 October 2003 Court overrules Ferry final objections
- 27 October 2003 Statement of Decision signed by judge (25 pages) ALL AGAINST FERRY
- 19 December 03 Ferry files appeal
- 14 January 2004 Court of Appeal acknowledges Ferry Abandonment of Appeal
- Last of January 04 King w/Mrs. King appeal to MPWMD in public meeting for help
- Early February 04 to PRESENT King files application and appeal to MPWMD to avoid losing his land
