WHEREAS, the Monterey Peninsula Water Management District (MPWMD) has examined the current and future water needs of the Monterey Peninsula in Technical Memorandum 2006-02 that sets forth targets for current and future water demand that now and will in the future affect the Monterey Peninsula Airport District, and



Authorizing Transmittal of Correspondence to the Monterey Peninsula Water Management District Approving Quantity Targets for Current Replacement and Future Water Needs of the Monterey Peninsula; Exempt from CEQA Requirements.

## **RECOMMENDATION**

That the City Council authorize transmittal of the attached letter.

#### **POLICY IMPLICATIONS**

The requested correspondence provides the Monterey Peninsula Water Management District (MPWMD) with the City's approval of current replacement and future water needs as calculated by MPWMD. Referenced future water needs of the City are based on the 2005 General Plan.

### **FISCAL IMPLICATIONS**

None.

#### **ENVIRONMENTAL DETERMINATION**

Exempt from the requirements of the California Environmental Quality Act.

## **ALTERNATIVES CONSIDERED**

The City Council could decline to authorize the City Manager to provide the requested correspondence but staff does not recommend this alternative as it would distinguish the City as uninvolved in the process of water planning.

#### **DISCUSSION**

On November 20, 2006, the Monterey Peninsula Water Management Board reviewed current replacement and future water needs for the Monterey Peninsula. The Board requested that each member agency (Peninsula cities, Airport District, and County unincorporated area) review and provide written comment on the proposed water targets.

MPWMD estimates current replacement need at 12,500 acre-feet per year. This replacement need would restore Cal-Am's existing diversions from the Carmel River that exceed their legal rights as well as existing diversions from the Seaside Basin that exceed Cal-Am's adjudicated rights. The table included as Attachment 2 identifies the specific replacement requirements.

MPWMD estimates the future need of its member agencies at 4,500 acre-feet per year. This

figure is based on "build-out" estimates established by the general plans of each member agency. MPWMD estimates that the future need of the City of Monterey is 705 acre-feet – a figure that is higher than staff's initial calculations. The table, included as Attachment 3, identifies specific future needs requirements.

Through work on MPWMD's Technical Advisory Committee, staff has reviewed replacement water needs and helped plan the future water needs figures. Both target yields have been thoroughly researched and calculated for consideration of a water supply project to satisfy outstanding requirements as well as the general plan needs of MPWMD member agencies. Staff believes the target yields are accurate, reasonable, and adequate. Accordingly, staff recommends transmittal of the attached correspondence approving the proposed target yields.

Dear Mr. Berger:

This letter is written in response to the November 20, 2006 Monterey Peninsula Water Management District (MPWMD) Board request for a determination of current and future water needs and as discussed in the Joint Policy Advisory(PAC)/Technical Advisory (TAC0 committee meeting held on January 9, 2007.

The City of Seaside City Council at their February 15, 2007 meeting confirmed the projected water needs determination as developed by the MPWMD in conjunction with the land use jurisdictions, the MPWMD Technical Advisory Committee (TAC) and the Policy Advisory Committee (PAC). The City Council confirmed the water needs projections as follows and directed staff to send a letter of confirmation:

• Current Replacement Need

12,500 Acre Feet per year

• Future Projected Need

4,500 Acre Feet per year

This confirmation and support for these amount of water projected is based on the understanding that these quantities are for planning purposes only and are to be used by the MPWMD Board in providing a response to the scope of alternatives to be included in the Environmental Impact Report (EIR) for a proposed desalination plant in Moss Landing, which California American Water Company (Cal-Am) has submitted for California Public Utilities Commission approval. The quantities above are not for future allocation purposes.

The City Council has also requested that their concerns be expressed with regards to the conditions and assumptions in which these numbers were derived. Please ensure that with these quantities, a description of how water consumption has been greatly affected due to the high conservation measures that the residents have utilized, the effects of State Order 95-10, and the significantly high cost of water should be acknowledged. Furthermore, assumptions on the implications of the adjudication of the Seaside Basin and the existing and future conditions of the

Los Padre Reservoir has and may in the future also greatly influence the analysis of these water quantities and should also be included when providing these estimates.

## Dear Dave:

As requested by your Board, the City Council of Sand City reviewed the existing and projected water demand figures developed by your staff. On February 6, 2007, the Council agreed to using those figures for evaluation purposes within the environmental impact report (EIR) on the Coastal Water Project (CWP). They also stated there should be a "reality check" in the EIR validating the 12,500 acre-feet per year being calculated as a "reasonable replacement of existing water demand", given the aggressive water conservation that has occurred since 1995.
