Fallon February 28, 2010 The California–American Water Company (Cal-Am) is the water company authorized to provide water in the urban service area of Monterey County and is regulating the orderly connection of water service for new development. Since water supplies are limited, the County Water Resources Agency administers a water waiting list for additional connections beyond which can not be presently served. CHOPIN has not listed themselves on the County's water waiting list.

The County's approval of this permit would circumvent the County's waiting list and then provide the land owner an opportunity to seek a "bail out" from Cal-Am in the likely event the well fails as set out in the discussion below. It should also be noted that Cal-Am will provide a backup to accommodate the sprinkler system now mandated under the building code, if not the property owner must provide a 4,999 gallon storage tank in a residential community either above ground, which would significantly impact the residential environment of the community or in the alternative, be buried underground, requiring the slating of granite subsurface material.

The development of private wells inside of the Cal-Am water service area could undermine the public utility's ability to provide adequate water supply to existing service connections, such that the potential cumulative impact of allowing private wells in public service areas could include the failure of the public water supply system due to the "bail-out" of failed wells such as Granite Ridge, not to mention the potential health safety risks of families using untested water.

Additionally, drilling individual wells on such small lots as those found in the Carmel Woods area is not practical, given the density of development in this area and the limited ingress and egress access for well drilling rigs to drill, repair or replace failed wells.

For these reasons, we request that the County and the California Coastal Commission deny the CHOPIN and POWELL applications for a permanent water supply well, to serve previously approved residential development within the urban Carmel Woods area.
