#### Attachment 5 - Permit and Approval Summary

As of November 5, 2009

##### City of Monterey: Use Permit No. 00-019

The City approved the Ocean View Plaza Project (the "Project") on June 1, 2004 and issued Use Permit No. 00-019. The City has granted extensions on the use permit and the tentative vesting map. The City recently amended the use permit so that the use permit will expire at the same time as the tentative vesting map.

##### LAFCO: Resolution No. 05-27

LAFCO approved the formation of the Ocean View Community Services District ("Ocean View CSD") on December 27, 2005 as reflected in LAFCO Resolution No. 05-27. The formation was challenged in court, but the trial court and the Sixth District Court of Appeals for California upheld the formation.

##### RWQCB: NPDES Permit Order No. R3-2007-0040

On July 7, 2007, the Central Coast Regional Water Quality Control Board ("RWQCB") approved the Project's discharge permit (NPDES Permit Order No. R3-2007-0040). Soon thereafter, the permit approval was appealed to the State Water Resources Control Board. The RWQCB sent a letter to the appellants on June 25, 2009, explaining that there did not appear to be any valid basis for the appeal.

##### California Coastal Commission: Application No. 3-08-013

The California Coastal Commission approved the Project on August 7, 2008. The final conditions were approved by the Coastal Commission at its meeting on December 10, 2008. This approval became final on January 11, 2009.

##### Regional Water Quality Control Board: Water Quality Certification ACOE File No. 23575S

On November 6, 2008, the revised technical drawings showing the Project's modified intake pipes as approved by the Coastal Commission were submitted. On February 26, 2009, the RWQCB sent notification that it has amended the Project's Technically Conditioned Water Quality Certification to permit the revised intake system.

##### U.S. Army Corps: (ACOE File No. 23575)

Under the National Environmental Policy Act, and with review by the U.S. Fish & Wildlife Service (File: 23575S) and National Marine Fisheries Service (Reference: 151422SWR2005SR00310:BS), the Army Corps has determined that the project has no impacts to rare, threatened or endangered species.

The Army Corps has also conditionally approved the construction of the offshore components (submerged intake and discharge) of the desalination system pursuant to section 404 of the Clean Water Act. Prior to providing final approval, the Army Corps needs to receive a copy of the approval from the Monterey Bay National Marine Sanctuary. It also needs to receive the Coastal Commission's determination of the Project's "Coastal Consistency" which will be

demonstrated by the Coastal Commission's issuance of the Coastal Development Permit for the Project.

Monterey Bay National Marine Sanctuary ("MBNMS")

The MBNMS is reviewing the Project's application. It recently requested some additional information that was provided to it.

Monterey Regional Water Pollution Control Agency ("MRWPCA")

The Project has received contingent approval from the MRWPCA, subject to MRWPCA's review of the final plans for the Project.

Monterey County Health Department ("MCH")

The Project has received contingent approval to construct the desalination facility from the MCH based upon 75% design drawings. The final design drawings will be submitted to the MCH for their review prior to construction. After the desalination facility is built, the MCH indicated it would be able to issue the permit to operate the desalination facility shortly after completion.
