Dear Monterey Peninsula Water Management District Board:

We respectfully request this Board to reconsider its decision on the above-mentioned matter reviewed at the hearing on April 18, 2011. For purposes of this letter "District" shall mean the Monterey Peninsula Water Management District.

Our request for reconsideration is based on the following:

- Based on the list of Board members on the District's website, not all of the Board members were present at the meeting, specifically Director Alvin Edwards and possibly others. Although we acknowledge that a majority were present, we believe that all of the Board members should vote on this matter, in case those members absent would vote differently and persuade the other Board members to reverse their decision. We also believe that the Board member(s) not present at the meeting should have an opportunity to review the letter we submitted during the hearing, including (without limitation) the right we reserved under 42 U.S.C 1983, as this may impact the absent Board member(s).
- The Board did not review our letter submitted at the hearing on April 18, 2011, before voting on our appeal. Before the Board voted on this matter at the hearing, the Chairman asked the Staff it had any comments on letter we submitted. The Staff representative, Ms. Pintar, indicated that she could not respond, because she had not had a chance to review our letter. The Board ignored the basics of procedural due process requirements of a fair hearing and reviewing all of the evidence presented, the Board immediately proceeded with voting on our appeal.
- Board members who were in attendance stated their decision was based on citizens relying on its rules. At the hearing, Director Markey kindly stated that she could understand that we may not be aware of these types of rules because we are from out of the local area, but the rules must govern. At the hearing we tried to mention that it is the District that did not follow its rules, which could have avoided this entire issue. See District Rules 23, 24 and
- At the hearing, Director Doyle indicated that the Board relies on the District staff to interpret the rules. This further illuminates our point - only the District Staff is able to interpret the rules, and only they are able to determine what is counted and what is not. As mentioned in our letter dated April 18, 2011, the District's fixture counting rules don't count every fixture in the house (for example, we have the same handheld faucet in the master shower and

master bath tub, but the District only counts the handheld faucet in the master shower), which is confusing, and which requires reliance on the District's fixture count inspection. Furthermore, this vesting of sole power and understanding in the District Staff has disadvantaged us and others similarly situated.

- At the Board's meeting on April 18, 2011, California American Water Company provided a
 report indicating that higher water rates have had the intended effect of reducing overall
 water usage in the District. There was not a District report on the current number of water
 fixtures now in the District, nor was there any report on how counting residential water
 fixtures has enabled the District to curtail water usage or better estimate water usage. This
 further demonstrates the point that the count of water fixtures is not key to estimating water
 usage rather, it is the cost of the water that determines water usage (i.e., water usage is
 inversely proportional to water rates).
- As mentioned in our letter submitted at the hearing, Mr. Anatoly Ostretsov of IDG, the architectural firm that prepared the plans to add the new bathroom under permit 30234 and the house remodel under 24754, relied on the latest inspection provided by the District when preparing the permit application. Mr. Jun Sillano, President of IDG, confirmed in the attached letter dated April 18, 2011, that the 2000 plans referenced in the District's report are "builder's plans" and during construction these plans likely changed. We were not owners of the Property back in 2000, and have no access to those plans. Mr. Sillano also indicated in the attached letter that the District does the final count of water fixtures, which is what Mr. Ostretsov relied upon when applying for permit 30234.
- To further confirm the statements made in our letter presented at the hearing on April 18, 2011, attached is a letter from Lennart Caspersen, General Manager of Herbeau, confirming that the fixtures in the downstairs bathroom has never come in a diverter model.
- The Staff report lists five remedies, and we indicated that each of these would either result in additional expense or were impossible to perform. Here is a summary:
 - o The staff suggests we could approach the County of Monterey for a permit for water from its Allocation. Mike Logsdon of the Monterey County Water Resources Agency informed us that the County has not had any available water allocation since 1994, and the District is aware of this. Thus, this not an option.
 - o The staff suggests that we purchase Entitlement water from Pebble Beach. This would cost us an additional \$10,000, after we've now completed building the bathroom. This significant additional cost was not included in our budget.
 - The Staff report suggests that we permanently remove the two "showerheads" (in actuality they are handheld faucets) that were installed when we purchased the house (See our prior correspondence and letter submitted at the hearing by Tony Sollecito). This would come at great expense approaching \$20,000 for the fixtures alone, not to mention re-plumbing and reinstallation of tile (if the current tile can be purchased). This significant additional cost was not included in our budget.

- The staff suggests that we can partially off-set our water fixture count by removing all of the toilets in the home (including the one we just installed less than a year ago per the District's permit 30234) and replacing the two dishwashers in the home (that are less than four years old). According to the District, we would still need to purchase additional water credits. This significant additional cost was not included in our budget.
- The Staff suggests replacing the current shower systems with a diverter. As mentioned previously, the Herbeau fixture does not come with a diverter it never has. Thus, this is not an option.

For these reasons, and those listed in our prior correspondence, including (without limitation) our letters dated July 28, 2010, March 25, 2011 and April 18, 2011, we respectfully request this Board to reconsider its decision indicated at the hearing on April 18, 2011. In addition, we respectfully request this Board to notify us in writing of its decision to reconsider our appeal on or before May 31, 2011.

All attachments, exhibits in prior correspondence, District rules, regulations, ordinances, documents provided as part of the California Public Records Request Act ("CPRA") request, and correspondence between the parties related to this appeal and the CPRA request are incorporated in this letter by reference.




