

Summary

Rule 172, Landscape Water Audits



Rule 11



- Revisions to the definitions of Recycled Water, Showerhead, Ultra High Efficiency Toilet (HET) and Urinal
- Amendment to definition of Shower, Each Additional Fixture, to clarify that an "additional fixture" is each Showerhead beyond the first, with the exception of a single hand-held Showerhead that operates on a diverter.



**Rule 24** 

**EFFECTIVE JAN 1, 2013** -- Table 1, Residential Fixture Unit Count, is amended to:

- Delete Ultra-Low Flush Toilets (ULF), consistent with amendments to Rules 142 and 143
- Add Ultra High Efficiency Toilets (UHET) with a value of 0.8 fixture units
- Delete the Residential fixture unit value for one gallon per flush Urinals to make Table 1 consistent with existing Non-Residential standards



### Rule 24-B-1-c

- Rule 24-B-1-c (Non-Residential Calculation of Water Use Capacity) is amended for consistence with the Residential calculation
  - Corrects an oversight during the adoption of Ordinance No.
    144 when the use of Estimated Total Water Use (ETWU) was added to the rule for consistency with the State Model Water Efficient Landscape Ordinance



**EFFECTIVE JAN 1, 2013** -- Table 4, High Efficiency Appliance Credits, is amended

- Deletes 0.4 fixture unit credit for High Efficiency Toilets (HET)
- Adds 0.5 fixture unit credit for UHET

**Rule 25.5** 


- Clarifies that credit for Instant-Access Hot Water Systems (IAHWS) is available for more than one Dwelling Unit on a Site if there are multiple Dwelling Units (i.e., condominiums, apartments, duplexes, etc.)
- Replaces "washing machine" with "Clothes Washer," consistent with terminology used throughout the rules





- Clarifies that a variance to Regulation II, Permits, must be requested prior to or within 90 days of a determination
- Outdated language in the first paragraph of Rule 90 is deleted





- Current maximum Cistern Rebate: \$6,250

**Rule 141** 

- Proposed maximum Cistern Rebate: \$6,375
- Due to limited funding for the Rebate Program, an amendment restricts Cistern Rebates to Sites supplied with water from the Monterey Peninsula Water Resource System



# Rule 142, Water Efficiency Standards

- "Grandfathers" Water Permits issued prior to the July 1, 2012, the Ordinance No. 151 implementation date. As of July 1, 2012:
- Showerheads must be designed and *manufactured* to meet the District's flow requirement of 2.0 gallons per minute
- Requirement for 3 minute shower timer (multiple showerheads is deleted
- Private Lavatory Sinks (e.g., hotel/motel guest rooms and hospital patient rooms) may flow at 2.2 gpm, (consistent with Building Code)
- Alternative water sources for indoor allowed uses are encouraged for new Non-Residential New Construction



# Rule 142, Water Efficiency Standards

#### **EFFECTIVE JAN 1, 2013**

- HET or UHET are specified as the District's toilet standard for Residential and Non-Residential New Construction, Changes of Ownership, Changes of Use, and Expansions of Use
- High Efficiency Urinals (or ones that uses less water) are required in Residential and Non-Residential New Construction, Changes of Ownership, Changes of Use, and Expansions of Use.



# Rule 143, Existing Non-Residential

- Showerhead and faucet flow rates are consistent with New Construction, Change of Ownership, Change of Use, and Expansion of Use requirements.
- Replacement of toilets in the MPWMD must be with HET or more efficient models after January 1, 2013.
- Retrofit requirements for Non-Residential uses currently scheduled for implementation on December 31, 2012, <u>are</u> <u>extended for six months to July 1, 2013</u>.










**Rule 172** 



- Clarifies that Landscape Water Budgets required for new Dedicated Irrigation Meters are based on the Estimated Applied Water Use as determined by the project's Landscape and Irrigation System plans
- Rule 172-E, Landscape Irrigation Restrictions, is amended to clarify the location of a property in the City of Carmel-by-the-Sea

#### Recommendation

- Staff recommends the Board adopt the first reading of Ordinance No. 151.
- A Negative Declaration pursuant to CEQA will be considered at second reading. An initial study and notice of intent to adopt a negative declaration has been circulated and comments will be received through May 2, 2012.
