INTRODUCTION

This second volume of the final EIR summarizes comments on the Draft EIR and responses to these comments.

The Draft EIR on the District's Water Allocation Program was released for public review on April 10, 1990. The public review period for the Draft EIR extended from April 10, 1989, to June 20, 1989. The District held two hearings on the Draft EIR on May 22, 1989 (one in the afternoon, one in the evening). The District also held a public hearing on the Draft EIR on June 12, 1989.

During the review period the District received both written and oral comments on the Draft EIR. Section II of this volume includes copies of the written comments and summaries of the oral comments. For reference purposes, each specific comment on the Draft EIR made by an agency, organization or individual is individually numbered (e.g., 1-1, 1-2, 1-3, etc).

Section I of this volume summarizes each specific comment on the Draft EIR (with a reference to the relevant chapter and page number in the Draft EIR) and provides the District's and Consultant's response to each comment.
