## 5. DISCUSS RANCHO CAÑADA VILLAGE SPECIFIC PLAN DRAFT ENVIRONMENTAL IMPACT REPORT

**BACKGROUND:** The proposed development project at the existing Rancho Cañada golf course adjacent to the Carmel River includes installation of drainage features that could impact the riparian corridor within the project limits. The project proponent will be required to obtain a River Work Permit from MPWMD for any work within 25 feet of the 10-year flood line, which corresponds approximately with the top of the river bank. At the time this packet was prepared, MPWMD staff had not completed a review of the Draft EIR. Staff will make an oral report about its review of the Draft EIR to the Committee at the March 6, 2008 meeting. Written comments on the Draft EIR are due to the Monterey County Planning Department 3March 7, 2008.

"The proposed project application [to Monterey County] consists of a Combined Development Permit, for the creation of a new, 281-unit, sustainable mixed-use residential neighborhood. The elements of the design proposal include a mix of "Smart 10 Growth" and "Traditional" neighborhood principles that involve the incorporation of established shopping facilities, schools,

open space, and 12 churches. Additionally, the development proposal attempts to meet the need for affordable housing in Carmel Valley. Fifty percent of the homes (140 units) are proposed to be deed-restricted as affordable and workforce units (per the pricing and eligibility requirements of Monterey County's Housing Ordinance). The proposed project also includes an evaluation of a possible extension of Rio Road."

**RECOMMENDATION:** No action is required. This is a discussion item.

# 6. PRESENTATION ON SAN CLEMENTE DAM SEISMIC SAFETY PROJECT ENVIRONMENTAL IMPACT REPORT/ENVIRONMENTAL IMPACT STATEMENT

**BACKGROUND:** Please see the staff note attached as **Exhibit B** for Item 13 from the February 28, 2008 MPWMD Board of Directors meeting for background information. Staff will show the presentations given on this project at the Board meeting by representatives of the California Department of Water Resources and the California Coastal Conservancy (CCC). At that meeting, two of the Directors (Kristi Markey and Dave Potter) suggested that the Board should consider writing a letter in support of the dam removal and re-route alternative. The Chair and Vice-Chair of the Board will meet to consider whether to place an item on the agenda for March 17, 2008 Board meeting concerning this.

District Engineer Andy Bell will give a description of the findings of this report and will also describe other projects that are in various phases of development for the Monterey Bay area.

**SUMMARY:** Paula Landis, Chief of the San Joaquin District of the California Department of Water Resources (DWR), will give a presentation on the Final Environmental Impact Report /Environmental Impact Statement (Final EIR/EIS) for the San Clemente Dam Seismic Safety Project. Trish Chapman of the California Coastal Conservancy will give a presentation on the Carmel River Reroute and Dam Removal alternative (also known as the "bypass" alternative), which is one of five alternatives evaluated in the Final EIR/EIS to address the flood and seismic safety concerns about the dam. A copy of each presentation is posted on the MPWMD web site (see February 28, 2008 Agenda). **BACKGROUND:** Engineering and geological studies presented in a June 1981 report by the DWR's Division of Safety of Dams (DSOD) concluded that additional investigations were needed to determine the safety of San Clemente Dam under conditions of Probable Maximum Flood (PMF) and Maximum Credible Earthquake (MCE), and directed remediation of the spillway gates. Subsequent studies found that San Clemente Dam could suffer structural damage leading to the potential loss of the reservoir during an MCE. In addition, under PMF conditions, water would overtop the dam, possibly eroding the right upper and downstream abutment areas and posing the risk of dam failure. Based on these findings, DSOD required that San Clemente Dam be brought into compliance to withstand loading from an MCE of 7.0 originating on the Tularcitos Fault (1.25 miles away) and to safely pass a PMF at the dam site of about 81,000 cubic feet per second.

California American Water (CAW) has filed a proposed design application with DSOD to strengthen the dam (also described as the "buttressing" alternative) to bring it into compliance with DSOD requirements.

### Exhibit B

The California Coastal Conservancy, in cooperation with the National Marine Fisheries Service, the Planning and Conservation League Foundation, and CAW, have completed investigations and preliminary designs for an alternative to buttressing the dam that involves re-routing the main stem of the Carmel River through the San Clemente Creek branch of the reservoir and removing the dam. District staff members Hampson and Urquhart participated on the California Coastal Conservancy-led technical review panel that provided input to bypass alternative feasibility engineering consulting studies recently completed. Ms. Chapman will highlight the outcome of those studies in her presentation.

DWR's Final EIR/EIS, certified on December 31, 2007, includes evaluation of five project alternatives: Dam Strengthening (CAW's proposed project); Dam Notching; Dam Removal; Carmel River Reroute and Dam Removal (California Coastal Conservancy's proposed project; and No Project. DSOD is evaluating the reroute alternative and will make a decision about which project to move forward with in the next few months.
