1. CALL TO ORDER/ROLL CALL

2. PUBLIC COMMENT – There was some discussion on whether the CRAC packet would be printed and mailed out or if electronic copies through e-mail were satisfactory. After the discussion it was found that all members of CRAC would like a mailed copy of the packet.

In addition, John Dalessio stated that many parks are not held in perpetuity and can be sold. However, the Monterey Peninsula Regional Park District (MPRPD) is now required to have a public vote to remove property from MPRPD ownership.

- 3. CONSENT CALENDAR Lance Monosoff made a motion to approve the minutes from the January 26, 2012 Regular Meeting, and was seconded by Thomas House. **The minutes were approved by a unanimous vote.**
- 4. UPDATE AND DISCUSSION ON CARMEL RIVER WATERSHED ACTIVITIES Lorin Letendre stated that the Carmel River Watershed Conservancy's (CRWC) is moving forward with the Carmel River Task Force to update the Action Plan. In addition, they are working with the Resource Conservation District (RCDMC) of Monterey County on a fish passage project in Potrero Creek. CRWC is also seeking to augment funds for Scenic Road protection and the Ecosystem Protection Barrier from County Service Area 1.
- 5. UPDATE ON CARMEL RIVER TASK FORCE Rami Shihadeh of RCDMC stated that the goal of the RCDMC is outreach, coordination, and education from the use of grant money. They currently have a grant from the Department of Conservation that started in May 2011 and goes for 3 years. This grant has helped restart the Carmel River Task Force activities. He also stated that a subcommittee will be created to look at updating the Action Plan for the Carmel River Watershed.

6. STAFF REPORTS

- a. Integrated Regional Water Management Program Larry Hampson reported that a request for proposals went out to update the Canyon del Rey drainage plan.
- b. Update on Carmel River Watershed Rainfall and Flow Conditions Thomas Christensen stated that for Water Year 2012 (October-March) the total amount of rainfall was 11.42 inches at San Clemente Dam and that the long term average rainfall was 18.99 inches for this period (annual average is 21.45 inches). This left us with a 60 percent of average rainfall for the October-March time period.
- c. Report on Schulte Road Bridge Replacement Project Larry Hampson reported that the 3.4 million dollar bridge replacement is moving forward in June.
- d. Report on Sleepy Hollow Ford Removal and Bridge Replacement Project Larry Hampson reported that he submitted a grant application to CDFG for funds to build the bridge. However, he did not get confirmation that the proposal was accepted because the computer system was having technical difficulties.
- e. Los Padres Dam and Reservoir Workshop Larry Hampson stated that this is on hold, pending results of a proposed feasibility study by Cal-Am on dredging Los Padres Reservoir.
